

# DOĞAN ŞİRKETLER GRUBU HOLDİNG A.Ş. (DOHOL)





## **RATING REVISION**

The Corporate Governance Rating (8.59) that has been assigned to Doğan Şirketler Grubu Holding Anonim Şirketi A.Ş. (Doğan Holding) on 3.11.2011 is hereby revised up to **9.03**.

Furthermore, Doğan Holding's degree of compliance with the Corporate Governance Principles is rated within the top Group 1 countries as categorized by the World Corporate Governance Index (WCGI), which is issued by SAHA on 24.01.2012. In consideration of Doğan Holding's determination to apply corporate governance principles, its willingness to manage this process dynamically and continuously, and finally the improvements affected during the twelve months lapsed since the publication of the previous rating report, the corporate governance rating of the company is revised as above.

Main improvements that affected the above revision are:

- A provision to maintain that transactions and decisions taken by the board of directors that do not comply with those Corporate Governance Principles which are defined as mandatory by the Capital Markets Board will be invalid and the company will fully comply with the Corporate Governance Principles published by the Capital Markets Board regarding the transactions of significance as defined by the Corporate Governance Principles, all transactions with related parties, and the issuance of guarantees like pledges and mortgages in favour of a third persons is incorporated in the articles of association of the company. Other mandatory revisions on the articles of association have also been implemented.
- 3 independent members are appointed to form the 9 strong board of directors. Number of executive members is less than half of the total number of the board members.
- The audit committee is formed entirely by independent board members and the corporate governance committee is chaired by an independent member.
- The company has executed a series of improvements with regard to compliance with the new Corporate Governance Principles inacted on 30.12.2011. These improvements will be reevaluated with our new rating methodolgy following its approval and a revision note will be issued.

The sub-section ratings are confirmed as follows:

# Rating Methodology

SAHA's methodology for rating the degree of compliance with the Principles of Corporate Governance is based upon the CMB's Corporate Governance Principles released on July 2003, as revised on February 2005.

The CMB based these principles on the leading work of the Global Corporate Governance Forum (GCGF), which has been established in cooperation with the World Bank and the Organization Economic Cooperation Development (OECD). After having incorporated the views and opinions of experts and representatives from the CMB, the Istanbul Stock Exchange, the Turkish Corporate Governance Forum, academicians, private sector representatives as well as various professional organizations and NGOs, the Principles were adopted to reflect national characteristics the conditions.

Within the Principles, "comply or explain" approach is valid. Some of these Principles are mere recommendations and their implementation thereof is optional. However, the explanation concerning the implementation status of the Principles, if not detailed reasoning thereof, conflicts arising inadequate implementation of these Principles, and explanation on whether there is a plan for change in the company's governance practices in the future should all be included in the annual report and disclosed to public.

The Principles consist of four main sections: shareholders, public disclosure and transparency, stakeholders and board of directors.

On the foundation of these Principles, SAHA Corporate Governance Rating methodology features over 400+ code During the rating process, criteria. each criterion is evaluated on the basis information provided by officials and disclosed company publicly. Some of these criteria can be evaluated by a simple YES/NO answer; others require more detailed analysis and examination.

SAHA assigns ratings between 1 (weakest) and 10 (strongest). In order to obtain the maximum rating of 10, a company should be in full and perfect compliance with the Principles (see Rating Definitions).

In compliance with the CMB's directive and to reach an overall Corporate Governance Rating, SAHA allocates the following weights to the four main sections of the Principles:

Shareholders: 25%

Disclosure and Transparency: 35%

Stakeholders: **15%**Board of Directors: **25%** 

To determine the final overall rating, SAHA utilizes its proprietary methodology which consists of subsection weightings and weightings for the criteria there under. A separate rating is assigned to each one of the main sections as well.

# Rating Definitions

Rating	Definition
9 - 10	The company performs <b>very good</b> in terms of Capital Markets Board's corporate governance principles. It has, to varying degrees, identified and actively managed all significant corporate governance risks through comprehensive internal controls and management systems. The company's performance is considered to represent best practice, and it had almost no deficiencies in any of the areas rated.
7 - 8	The company performs <b>good</b> in terms of Capital Markets Board's corporate governance principles and has qualified to be included in the ISE's (Istanbul Stock Exchange) Corporate Governance Index. It has, to varying degrees, identified all its material corporate governance risks and is actively managing the majority of them through internal controls and management systems. During the rating process, minor deficiencies were found in one or two of the areas rated.
6	The company performs <b>fair</b> in terms of Capital Markets Board's corporate governance principles. It has, to varying degrees, identified the majority of its material corporate governance risks and is beginning to actively manage them. Management accountability is considered in accordance with national standards but may be lagging behind international best practice. During the ratings process, minor deficiencies were identified in more than two of the areas rated.
4 - 5	The company performs <b>weakly</b> as a result of poor corporate governance policies and practices. The company has, to varying degrees, identified its minimum obligations but does not demonstrate an effective, integrated system of controls for managing related risks. Assurance mechanisms are weak. The rating has identified significant deficiencies in a number (but not the majority) of areas rated.
<4	The company performs <b>very weakly</b> and its corporate governance policies and practices are overall very poor. The company shows limited awareness of corporate governance risks, and internal controls are almost non-existent. Significant deficiencies are apparent in the majority of areas rated and have led to significant material loss and investor concern.
