



DATA SUBJECT APPLICATION FORM

GENERAL EXPLANATIONS

The rights of persons defined as data subjects in the Law on the Protection of Personal Data numbered 6698 (“LPDP” or “the Law”) or their legal representatives (“hereinafter referred to as “Applicant” or the “Data Subject”) to make requests about processing of personal data are regulated in article 11 of the LPPD.

Pursuant to the first paragraph of Article 13 of LPPD, applications associated with such rights must be submitted to Doğan Şirketler Grubu Holding A.Ş. ("Doğan Holding" or the "Company") as data controller either in writing or by other means set by the Personal Data Protection Board (“Board”). Your requests shall be answered **as soon as possible or in thirty days of its receipt by Doğan Holding, at the latest** according to the nature of your request.

APPLICATION METHOD

- Application by Mail or in Person: An application can be submitted by mail or in person to the address 'Burhaniye Mahallesi, Kısıklı Caddesi, No: 65 34676 Üsküdar / İstanbul' with the application form filled and signed by the Applicant, accompanied by identity-evidencing documents.
- **Application by Registered Electronic Mail (KEP) Address:** An application can be made by sending the petition signed by the Applicant from his registered e-mail address (KEP) or sending the Application Form to the address doganholding.kvkk@hs02.kep.tr via e-mail.
- **Application via Electronic Mail using Mobile Signature or Secure Electronic Signature:** An application can be made by sending the petition signed by the Applicant with the mobile signature or secure electronic signature or filling in and sending the Application Form to the address doganholding.kvkk@hs02.kep.tr via e-mail.
- **Application by E-mail:** The applicant can make an application to Doğan Holding the data controller, by sending an e-mail to the address kvkk@doganholding.com.tr using his electronic mail address previously notified to Doğan Holding and registered in Doğan



Holding's system. In this application, Doğan Holding has the right to request additional identity verification depending on the subject of the request.

In addition, applications can be made via a Notary Public or other methods that are legally valid and allow to verify identity. In applications, it is recommend that the matters mentioned above are complied to the extent permitted by the relevant method as this will increase the possibility that the application is concluded positively and in a short period of time.
